#### **Did You Know?**

#### Significance of SIX\_DECIMALS\_PERCENT\_SIZE

The PRPM property in Finacle Online Banking version 11.x on wards is related to transformers in loan a ccount requests. The response length depends on the SIX\_DECIMALS\_PERCENT\_SIZE value in Finacle Core Banking:

- If the SIX\_DECIMALS\_PERCENT\_SIZE='Y', 6 decimal points are displayed in the interest rate field
- If SIX\_DECIMALS\_PERCENT\_SIZE='N', only 4 decimal points are displayed
- The value of this property in Finacle Core Banking and Finacle Online Banking should always be in sync. The SIX\_DECIMALS\_PERCENT\_SIZE PRPM property is used to set this flag in Online Banking. In Finacle Core Banking, the SIX\_DECIMALS\_PERCENT\_SIZE flag is set in the uniser.cfg file and uniser start script.

Here is a sample response where interest rate field have 6 decimal points: FIELD[125]=011xxxxxxBxxxxxxx MOxxxxxx xxxxA

20130912048000LNR15009.950000E20180831

In the above example, Finacle Core Banking would give a response where the interest rate is shown in a 10-character format while containing 6 decimal points. In this scenario, the PRPM property SIX\_DECIMALS\_PERCENT\_SIZE in Finacle Online Banking should be set to Y

### **Best Practices**

### Relevance of "Include Delay Timeout" Parameter in C24 Transactions

At C24, if the transaction request is not processed within the timeout parameter set, then the timeout response is sent to Channels. The timeout parameter is maintained at both CBC and Uniser. Both the services would switch on the timer once the request is received.

If CBC and Uniser are on different servers, there can be a time delay in the network or while picking up requests at the Uniser. In such cases, Uniser would start processing the request with some delay and post the transaction in Finade Core Banking within its timeout period. Still the CBC mays end a timeout response to the Channels in case there is no response from Uniser within the timeout parameter set at CBC. In this scenario, the customer will receive a timeout response whereas the corresponding customer account will be debited.



#### What's the solution?

The INCL\_DELAY\_IN\_PROC\_TIMEOUT parameter can be set as Y in the Uniser start script. This will ensure that Uniser includes a network delay while calculating the processing timeout at Uniser.

- If N, Uniser would consider the time it has received the request, irrespective of when the CBC s ends the request to Uniser
- If Y, Uniser would consider the time when CBC sends the request

E.g. if the Uniser processing timeout is 12 seconds and there is a network delay of 10 seconds:

- When INCL\_DELAY\_IN\_PROC\_TIMEOUT = N, Uniser will timeout if it fails to complete the processing within 12 seconds
- When INCL\_DELAY\_IN\_PROC\_TIMEOUT = Y, Uniser will timeout if it fails to complete the processing within 2 seconds

## Monitoring and Housekeeping Activities

Monitoring and housekeeping activities help ensure that Finade systems are operating seamlessly and is sues, if any, are addressed proactively. Each bank has few of its own standard activities. Based on the incidents reported by different banks, we have listed some key activities to be followed.

- Monitor utilization of licenses
- Monitor batch job execution status and take appropriate steps for failed batch jobs
- Clear stale entries in LGI sessions. A large number of inactive LGI entries may create problems during application login
- Monitor the Finacle DB sequence limit. Few of the application sequences like SWIFT\_MSG\_SRL\_NUM\_SEQ, CHRG\_NUM\_SEQ\_DC are not
  recycled and need to be reset on reaching the maximum limit
- Monitor the expiry date of all certificates
- Clear server logs and a pplication level logs regularly
- Periodic archiving and purging of data, that is no longer actively used, helps in faster processing. E.g. Regular purging of RTT table helps in faster execution of duplicate checks and reversal checks.
