
#### All About SSO Session Clean Up

Product: Finacle Single Sign On Version: 10.x

Once the user logs into Finacle, their credentials are validated through SSO (Single Sign-On) and user sessions audit info is stored in the SSO\_AUDIT table. The audit table will store all user activity pertaining to LOGINS, LOGOUTS and even forced LOGOUTS also. For a given session, ideally there would be one entry for LOGIN and one entry for LOGOUT in the SSO\_AUDIT table. When the user performs a normal LOGOUT in the AUDIT\_DATA column, the same will be stored as MODE=N. While for a forced LOGOUT (example close IE browser without signing out of Finacle), the audit will be stored as MODE=F.

The **SSO\_AUDIT** table data enables SSO to check whether a user session is active and will display the below popup when the user tries to login again on a different browser:



There is an **automatic session clean up** task which will clean up idle user sessions regularly, as per the clean-up interval set in the **SSOServerConfig.conf** file. If a user is idle for more than the maximum inactive time configured during SSO cleanup task, that user session will be cleared. If the user tries to login again, then they will be able to login without the error "User is already logged in". It is to be noted that in Audit table, there will be entry only for the LOGIN without any entry for LOGOUT when session is cleared by cleanup task. Refer the screenshot below where the Audit entry is only for LOGIN but no entry for LOGOUT.

**Interval for SSO cleanup** task should be configured in **SSOServerConfig.conf** found in the frontend path **/common/config/SSO**. The config file is encrypted and can only be decrypted with **Infosys internal Archie Maintenance Tool SSO Configuration Decryptor**.




#### **Product: Finacle Finanz Tools**

#### **Split Loan Calculator**








#### Spend Analyzer
